2. **12** posts of Junior Resident are horizontally reserved for Persons with Benchmark Disability (PwBD) as per DOPT, Govt. of India Rules issued from time to time.

3. Eligibility Criteria: -

Duration of Residency: - One year w.e.f. 01.01.2026 to 31.12.2026 in two subjects for six Months each.

Pay Scale : Rs. 56100/- in Pay Level-10 in the Pay Matrix as per 7th CPC + NPA and Other allowances as admissible as per Govt. of India Rules.

Qualification criteria for Junior Resident (Non-PG) MBBS: -

MBBS Degree from a Recognized University & must be registered with Delhi Medical Council (DMC).

- Candidates must have completed their Internship on or after 01.01.2024.
- FMGE Certificate for FMG candidates.
- DMC Registration is mandatory. (Receipt will be considered but original DMC Registration required before the joining, if selected).

Qualification criteria for Junior Resident (Non-PG) BDS: -

- BDS Degree from a Recognized University
- Permanent Registration Certificate from Delhi Dental Council / State Dental Council.
- Candidates must have completed their internship on or after 01.01.2024.

Mode of Selection:

- A Screening Test comprising a written examination of one hour duration based on MCQs for the maximum marks of 60 numbers will be conducted.
- 01 marks will be awarded for a correct answer and a penalty of $\frac{1}{4}$ marks for a wrong answer.
- No negative marking for non-attempted question.
- Candidates three times the number of vacancies (or less if not available) who qualify screening test will be called, as per merit list.

SC/ST/PWD candidates - No fees

(iii) For EWS candidates - submit copy of Income & Asset Certificate as per given Annexure-II having date of issue on or after 01.04.2025 valid for financial year 2025-26 **Candidates must ensure that he/she falls under EWS category otherwise their candidature will be rejected.**

11. The tenure of Junior Resident is one year including any service rendered earlier as Junior Resident on adhoc/regular basis in any Govt. of India/State Government hospital/institution.
12. Other service conditions will be applicable as per service conditions prescribed from time to time by the Govt. of India.
13. The candidate who is already employed should submit No Objection Certificate from present employer at the time of joining.
14. The candidate must bring all the uploaded certificates and any other relevant documents in original for document verification at the time of joining.

16. No TA/DA will be paid for attending the exam & interview.
